

beneficiaries & grants

Springboard Foundation focuses on 5 different areas, all for the improvement of the lives of the children in the Philippines. These are Health, Nutrition, Education, Community Development and Relief Operation. As stated on the illustrated graph, 50% of the completed projects were allotted to education amounting to 1,484,935 Pesos consisting of scholarship programs and educational materials. Health covered 10% of the total projects with 298,636 Pesos worth of public hospital renovations, medicines and supplies. The total emergency relief operations conducted amounted to 630,488 Pesos. Nutrition projects worth 228,000 Pesos involved feeding programs and 11% of the completed projects were allocated to community development programs.

BREASTFEEDING AREA AT DR. FABELLA MEMORIAL HOSPITAL

Since 87 years Dr. Jose Fabella Memorial Hospital endures, endears and endeavors for comprehensive, competent and compassionate health services, one of which is the breastfeeding program.

Last June 2008, the Breastfeeding Area was renovated through the generous support of DSM Nutritional Products in partnership with Springboard Foundation and Give A Life Foundation.

The renovation included the tiling of the floors, repair and repainting of the walls, replacement of the ceiling and the electric fittings. Moreover, to maximize the comfort of every mother, new cosy sectional sofas were added to the room.

Mothers are now more relaxed and at ease when they are breastfeeding which should increase their milk production. The ambiance has drastically changed from an uncomfortable feel to a restful place for the moms and their little angels.

All these changes improved not only the aesthetic appearance of NICU Ward, but also the quality of neonatal care in a clean, safe and healthy environment.

The mothers are truly grateful for this blessing. They would like to extend their sincerest gratitude to the supporters who never cease to lend their helping hand. Everyone at Dr. Jose Fabella Memorial Hospital is just as thankful.

The Essential Nutritional Program was very helpful. A lot of children gained weight and were happy because of the progress in their own individual health status. They became active and well participative. The nourishment that they received from the program also enabled the children to better perform in the class as observed by the teachers.

Parents are very grateful that their children were given free meal 3x a week as they know it is vital for their child's development and growth. This they know will help a lot in their learning and development. Also, it is a fact that they can hardly afford to provide quality meal

Parents and children made letters and cards expressing their gratitude towards the help and development they received due to the nutritional food provided to them.





In Hope Worldwide monthly monitoring they noticed that they were increasing in their height and weight status. Also, children learned to eat a nutritious food like vegetables and fruits which they don't eat before. Parents were also educated on how to prepare nutritious food that they can afford with the little earnings they have. They are very excited to serve their children during feeding time.school in the morning and are served with nutritious breakfast. While the 2nd and 3rd degree malnourished gets 3 meals from it.

One of the beneficiaries of the feeding program is Eli Singcol Jr., 6 years old, a son of Mr. and Mrs. Singcol who have five (5) siblings also living in Baseco. Eli is a student of the Day Care Program that was identified malnourished and was referred to University of Sto. Thomas Hospital, MALward (Maximum Assistance for Life ward) Division. He is suffering from severe stunting, wasting and acute nasopharyngiis. He was later diagnosed of pheumonia and positive PTB exposure. The teachers earlier also observed that he had a hard time coping and understanding that was later assessed that he was delayed on growth. Last June 2007, he was admitted to address his condition and was discharged last August and now active and participative in the class.

Special thanks goes to DSM Nutritional Products for their generous donation to Virlanie Foundation. One of Virlanie Foundation's program is the Mother and Child Home, established in June 1996. It serves as a temporary shelter for young unwed or battered mothers, victims of incest and rape as well as those without family in Manila. The home also cares for babies and toddlers who were rescued from the street. The donation was used to fund the nutritional needs of

Virlanie Foundation helps the mothers to prepare for life after discharge from the Mother and Child Home, both if their want to return to their families or if they want to live independently.

For the babies and toddlers, their families are being assessed by a social worker to see if they are capable and willing to take care of the babies and toddlers. In some cases the children are being surrendered for adoption.



Health fair activities encourage children to learn health and nutrition through creative means other than hearing lectures and reading materials. Puppetry easily captures and holds children's attention. Through learning by-doing methods, puppetry will also encourage creativity in members of PAI's Arts Club. Although, the health fair kit already has ready-made scripts, PAI will utilized puppetry to facilitate group story creation, music, appreciation, song rap/ composition, voice modulation and other forms of creative expressions for children and youth.

We have audited the accompanying statements of asset and fund balance of Springboard Foundation, Inc. (a nonstock, nonprofit corporation) as of December 31, 2008 and 2007, and the related statements of revenues and expenses and statements of changes in fund balance for the years then ended, and a summary of significant accounting policies and other explanatory notes.

Management's Responsibility for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

1. Corporate Information

Springboard Foundation, Inc. (the Foundation) was registered as a nonstock, nonprofit corporation with the Philippine Securities and Exchange Commission on November 15, 2002. It's purpose, among others, is to improve the quality of life of Filipinos, especially the abandoned and marginalized children, through various social, economic and cultural projects.

Revenues of the Foundation are exempt from income tax under conditions set forth in Section 30(e) (as amended) of the National Internal Revenue Code subject to the representations stated in its application for registration.

The registered office address of the Foundation is 2/F Interadent Building, Pascor Drive, Santo Niño, Parañaque City.

The financial statements of the Foundation as of and for the years ended December 31, 2007 and 2006 were authorized for issue by the Board of Trustees on March 10, 2008.

2. Summary of Significant Accounting Policies

Basis of Preparation

The financial statements of the Foundation have been prepared on the basis of cash receipts and disbursements. Revenues and related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the liability is incurred.

Foreign Currency Translation

The financial statements are presented in Philippine peso, which is the Foundation's functional and presentation currency. Transactions in foreign currencies are initially recorded in the functional currency rate ruling at the date of the transaction. Monetary assets and liablities denominated in foreign currencies are retranslated at the functional currency rate of exchange ruling at the balance sheet date. All differences are taken to the statements of revenues and expenses.

Cash

Cash consists of cash on hand and with banks.

Donations in kind

Donations in kind are stated at fair market value when the donations are received and given. In kind donations pass through the Foundation to be given to various beneficiaries.

Subsequent Events




3. Fund Raising Project

The Foundation's fund raising project pertains to charity boxing events. Income from the events arises from ticket sales and auction proceeds. Revenues generated from said events amounted to ₱2,236,500 and ₱2,520,160 in 2007 and 2006, respectively. Related cost amounted to ₱871,574 and ₱197,969 in 2007 and 2006, respectively.




